Why We Collect Information and How Long

The DFW FORUM collects your information solely to keep you informed about our upcoming meetings, events, and relevant organizational updates.

We only retain your personal information for as long as you wish to remain connected with us and receive our communications. Once it is no longer necessary or relevant for these purposes, we remove data connected to you or we archive it on our servers.

Use / Disclosure of Information Collected

The DFW FORUM is committed to maintaining the confidentiality of our network. We do not sell, rent, or lease our contact lists to third parties.

As a service for our participants and to foster professional engagement, we do provide a complimentary list of meeting registrants upon request. We limit the disclosure to the name and organization of the registered attendees. By sharing your personal information with the DFW FORUM, you consent to its use and storage in accordance with these guidelines.
